

- (4) Format for School Transfer Certificate (T.C.) is enclosed herewith. You are required to print Transfer Certificate(s) only as per the format given. School No., Affiliation No. and address of the school should be printed on the Transfer Certificates. Transfer Certificates are to be issued to student(s) at the time of leaving the school. Countersignature of the Board's Officer on Transfer Certificate(s) is necessary. For this purpose, you may send T.Cs with self addressed envelope affixing proper postal stamps to return the same by Speed Post.
- (5) Enclosed proforma for school details be filled and forwarded within one month. At the time of changes, the same be filled once again and forwarded to this office through speed post, by email also to rocbschbsr@rediffmail.com.

With reference to your application dated 20.06.2017 and subsequent correspondence with school, in this regard, I am directed to convey sanction for Regular Affiliation to the above said school for Senior School Certificate Examination (Classes XI to XII) w.e.f. 01/04/2016 onwards in the following subjects:-

Core Language : English.

Elective Subjects: Hindi, Physics, Chemistry, Biology, Accountancy, Business Studies, Economics, Computer Science, Informatics Practice, Physical Education, Music.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of Regular affiliation for secondary classes:-

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. The school must follow Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No:Acad-14/2017, dated 21.03.2017.
4. The school must submit its information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in.
5. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
6. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

8. It will continue to pay Annual Fee of Rs.3000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee in CBSE by D.D./Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet Vihar, Delhi-110092
9. Annual fee has been received upto **31/03/2018**.
10. **The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates.**
11. **Special condition to be completed within 03 months.**

1. **The school is required to appoint Special Educator as per rule 13(11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.**
2. The school is required to procure more books subject to minimum of 1500 books in the school library and submit copy of purchase bill as evidence for same.


