Q4. A. B and C were partners in a firm. On 1st April, 2018, their capital stood at Rs. 4,00,000; Rs. 3,00,000 and Rs. 2,00,000 respectively. As per the provisions of the Partnership Deed.

A was entitled to a salary of Rs. 5,000 per month.

Partners were entitled to interest on capital @ 10% p.a.

The net profit for the year ended 31st March 2019, Rs. 3,00,000 was divided among the partners without providing for

the above items. Showing your working clearly, pass an adjustment entry to rectify the above error.

Q5. A, B and C were partners in a firm having capitals of Rs. 50,000; Rs.50,000 and Rs. 1,00,000 respectively. Their current account balances were A: Rs. 10,000; B: Rs. 5,000 and C: Rs. 2,000 (Dr.). According to the Partnership deed the partners were entitled to an interest on capital @ 10% p.a.

C being the working partner was also entitled to a salary of Rs. 12,000 p.a. The profits were to be shared as:

i. The first Rs. 20,000 in the proportion to their capitals.

ii. Next Rs. 30,000 in the ratio of 5:3:2.

iii. Remaining profits to be shared equally.

The firm made a profit of Rs. 1,72,000 before charging any of the above items. Prepare the Profits and Loss Appropriation Account and pass the necessary Journal entry for the appropriation of profits.
